

ADVERTISEMENT FOR BIDS

**2020 CDBG Project
for the
Hart County Water and Sewer Authority**

Sealed bids will be received by the Hart County Water and Sewer Authority, Hart County, Georgia (OWNER), for furnishing all materials, labor, tools, equipment, and any other miscellaneous items necessary for the construction of the 2020 CDBG Project in Hart County, Georgia.

This is a Section 3 Covered Project under the HUD Act of 1968 and Section 3 Residents and Business Concerns are encouraged to apply.

The County is committed to providing all persons with equal access to its services, programs, activities, education, and employment regardless of race, color, national origin, religion, sex, familial status, disability or age.

Bids will be received at Hart County Water & Sewer Authority, 200 Arthur Street, Hartwell, GA 30643 until 12:00 p.m. on July 13, 2021. Any bid received after said time and date of bid opening will not be considered by OWNER. Bids will be publicly opened and read aloud at this time and location. All bids will be evaluated by OWNER and the project will be awarded, if it is awarded, within fourteen (14) days of the bid opening. If a bidder is not selected within fourteen (14) days of the bid opening, any bidder that is determined by the OWNER to be unlikely of being selected for contract award shall be released from their bid.

The Project consists of, but is not limited to the following major elements:

Approximately 12,055 L.F. of 8-inch PVC waterline, 20,220 L.F. of 6-inch PVC waterline, 1,135 L.F. of 2-inch PVC waterline, 775 L.F. of 8-inch and 6-inch freebores, 75 L.F. of 6" PVC Horizontal Directional Drilling, 150 L.F. of 8" PVC Horizontal Directional Drilling, 55 L.F. of 12-inch steel casing with 6-inch DIP jack and bore, 65 L.F. of 16-inch steel casing with 8-inch DIP jack and bore, 29 each fire hydrants, (14) 8-inch gate valves, (19) 6-inch gate valves, (2) Waterline connections via 12"x8" Tapping Sleeve with 8" Gate Valve, (1) Waterline connection via 12"x6" Tapping Sleeve with 6" Gate Valve Line termination with fire hydrant assembly, (3) Line termination with fire hydrant assembly, (2) Line termination with flush hydrant assembly, approximately 60 service connections and related appurtenances.

Time of completion for all work associated with this project shall be two-hundred-seventy (270) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

OWNER requires a bid bond* or a certified cashier's check in the amount of five percent (5%) of the total bid to be enclosed with the bid at the time of bid opening. Cashier's check will be made payable to the Hart County Water & Sewer Authority.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds* in the amount of one-hundred percent (100%) of the total bid.

Each bid must be submitted in a SEALED ENVELOPE, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, "**Bid for the 2020 CDBG Project for the Hart County Water and Sewer Authority**" and be labeled with the **BIDDER'S State of Georgia Utility Contractor License Number**. If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

All Bids must be made out on the bid form of the type bound in the Contract Documents, in accordance with the instructions in the Information for Bidders. No interlineation, additions, or deletions shall be made in the proposal form by the BIDDER.

Any and all Bids received without the aforementioned qualification criteria enclosed, will be returned to the BIDDER.

CONTRACTORS and SUBCONTRACTORS bidding on this Project will be required to comply with all Federal, State, and local laws, including, but not limited to, the following:

- Title VII for the Civil Rights Act of 1964 and Executive Order 11246
- 29 CFR Parts 1, 3, 5, 6, and 7 Davis-Bacon Act
- 40 U.S.C. 327-333 Contract Work Hours and Safety Standards Act
- 24 CFR Part 135 Section 3

The OWNER has acquired all the local, State and Federal permits in connection with this project with the exception of the Georgia Land Disturbance permit. All permits will be acquired before the Notice to Proceed is executed.

OWNER requires that no trees will be removed during the NLEB, Grey, and Indiana Bat's maternity/roost period (May through June) should removal become necessary.

OWNER reserves the right to waive any informalities or to reject any or all Bids, to evaluate Bids, and to accept any Bid which in its opinion may be in the best interest of the OWNER. No Bid will be rejected without just cause.

No BIDDER may withdraw his bid within the time limit specified in the Instruction to Bidders (Section 00100).

Surety companies executing Bonds must appear on the US Treasury Department's most current list (Circular 570 as amended) and be authorized to transact business in the State of Georgia. In lieu of a Payment Bond, a Cashier's Check, Certified Check, or Cash may be submitted in an amount not less than the total amount payable by the terms of the CONTRACT.
