1. Section 00030 Advertisement for Bid, page 3. The first paragraph on this page has been added. This paragraph concerns the Build America, Buy America Act (BABAA).
2. Section 00100 Instructions to Bidders, page 8. Item 35 has been added. This discusses a request for substitute or “or equal” in regards to the Build America, Buy America Act (BABAA).
3. Section 00300 Bid Form, page 1. The last two sentences on this page have been added. This references that the Bidder is familiar with laws and regulations that may affect cost, progress and performance of the work, including BABAA requirements.

***This agreement is for services related to a project that is subject to the Build America, Buy America Act (BABAA) requirements under Title IX of the Infrastructure Investment and Jobs Act ("IIJA"), Pub. L. 177-58. Absent an approved waiver, all iron, steel, manufactured products, and construction materials used in this project must be produced in the United States, as further outlined by the Office of Management and Budget's Memorandum M-22-11, Initial Implementation Guidance on Application of Buy America Preference in Federal Financial Assistance Programs for Infrastructure, April 18, 2022.***

**This project is being funded through a Community Development Block Grant (CDBG), with funding provided by the U.S. Department of Housing and Urban Development and Administered by the Georgia Department of Community Affairs. The Contractor/Bidder's attention is called to the Mandatory Section 3 solicitation package, the Specific Project Requirements, and the Applicable David-Bacon Wage Rate Determination.**

**\* Surety and insurance companies must have an AM Best rating of A-6 or greater, be listed in the Federal Registry of Companies holding Certificates of Authority and Acceptable Sureties on Federal Bonds, be licensed by the Georgia Insurance Department and the Georgia Secretary of State to do business in the State of Georgia. Surety companies executing Bonds must appear on the Treasury Department's most current list (Circular 570 as amended) For Performance Bonds less than \$300,000 an irrevocable Letter of Credit from a bank as defined in O.C.G.A. Code Section 7-1-4 may be submitted in lieu of a bond. In lieu of a Payment Bond, a Cashier's Check, Certified Check, or Cash may be submitted in an amount not less than the total amount payable by the terms of the CONTRACT.**
